CORRIGENDUM FOR GUIDELINES FOR APPLICANTS

Reference: 700002491-01

1. Reason for change

The Guidelines for Applicants section 2.1. “Eligibility criteria” specifically defines eligibility criteria for applicants under this Call for proposals. In the mentioned section it is foreseen, inter alia, that to be eligible for a grant, the lead applicant must have an annual turnover above €200.000 and at least double the grant size (applicable only for the lead applicant).

After having received a number of requests for clarification of this criterion and how it should be interpreted, we, hereby, consider this as a technical error and the contracting authority has introduced the modifications as below.

Due to modification introduced regarding the eligibility requirement, in addition the minimum amount of grant is introduced.

2. Text to be corrected in the original Guidelines for applicants

1.1. FINANCIAL ALLOCATION PROVIDED BY THE CONTRACTING AUTHORITY

Instead of:

Size of grants

Any grant requested under this call for proposals must not exceed **EUR 200.000**. The optimal grant requested under this call for proposals is EUR 125.000.

Read:

Any grant requested under this call for proposals must fall between the following minimum and maximum amounts:

- minimum amount: **EUR 50.000**
- maximum amount: **EUR 200.000**

The optimal grant requested under this call for proposals is EUR 125.000.



2.1.1. Eligibility of applicants (i.e. lead applicant and co-applicant(s))

Instead of:

Lead applicant

To be eligible for a grant, the lead applicant must:

- be a legal person,
- be non-profit-making,
- be a non-governmental organisation, as defined by the [Law of Ukraine 'On Public Associations'](#) No. 4572-VI of 22 March 2012,
- be effectively established in¹ Ukraine,
- be directly responsible for the preparation and management of the action with the co-applicant(s), not acting as an intermediary,
- not be in any of the exclusion situations listed in Annex E of the guidelines, **and**
- have an annual turnover above €200.000 and at least double the grant size (applicable only for the lead applicant).

Read:

Lead applicant

To be eligible for a grant, the lead applicant must:

- be a legal person,
- be non-profit-making,
- be a non-governmental organisation, as defined by the [Law of Ukraine 'On Public Associations'](#) No. 4572-VI of 22 March 2012,
- be effectively established in² Ukraine,
- be directly responsible for the preparation and management of the action with the co-applicant(s), not acting as an intermediary,
- not be in any of the exclusion situations listed in Annex E of the guidelines, **and**
- have an annual turnover above €200.000 **or** at least double the grant size, **whichever is the lower** (applicable only for the lead applicant).

3. Other additional information

All other terms and conditions of the original Guidelines for grant applicants remain unchanged. The above alterations and/or corrections to the original Guidelines for grant applicants are integral part of the Guidelines for grant applicants.
