Yes, pilot projects are very much encouraged to participate in the call if it aligns with the project priorities and action eligibility (Eligibility criteria for the action and costs are outlined in Sections 2.1.3 and 2.1.4 of the GfA). Please be advised, that Section 2.1.3 of the GfA foresees restrictions for types of actions which are not eligible, which include “actions focusing exclusively on infrastructure without accompanying capacity building or service delivery components”, therefore planning any actions focused on pilot projects, be mindful of the requirements.
2		Can more than one project be approved for funding within the same country?	Yes, more than one project can be funded in the same country, as there is no country-level limit and applications are selected based on eligibility and their evaluation score. Actions implemented in more than one of the 6 target countries are encouraged and have a better chance to receive higher points during the evaluation on regional coverage. (Evaluation and selection of applications grids are outlined in Section 2.3. of the GfA).  Please be advised there are limitations on number of applications and grants per applicants (refer to section 2.1.3 of the GfA).
3		What factors might decrease a country's likelihood of securing the funding approval?	Actions must take place in and be addressed to one or more of the following countries: Antigua & Barbuda, Dominica, Grenada, Saint Kitts & Nevis, Saint Lucia, and Saint Vincent & the Grenadines. The call does not apply country quotas nor does it favour any specific country among these six.
